**NARRATIVE INFORMATION**

On 6/4/18 at 0933 hrs. an unknown male calling from an unknown number contacted APD Investigations. The caller wished to remain anonymous. The caller advised that he was contacting APD as he was concerned that the below documented incident was handled internally in the church rather than internally and criminally.

In summary, but not verbatim, the caller advised that Paxton Singer, a student pastor, recently resigned from Harvest Bible Chapel. Harvest Bible Chapel has seven chapters, one of which is in Aurora. Singer was assigned to several of the chapters, including the Aurora and Elgin location.

According to the caller, on an unknown date and unknown time span Singer exchanged approximately 1,700 text messages with [REDACTED], many of which were inappropriate and/or sexual in nature (asking for pictures of [REDACTED] in his underwear). [REDACTED], learned of these messages and brought the issue to the attention of a Harvest Bible Pastor. According to the caller the issue was handled internally. At first [REDACTED] was offered counseling, which he did not cooperate with. [REDACTED] was then given the option to resign, which he did.

The caller also advised that [REDACTED] was involved in sending approximately seven to eight thousand text messages to [REDACTED] members of the various Harvest Bible Chapels.

I informed the caller that in order to open an investigation I would need Victims to come forward and file police reports. At this time the caller informed me of juvenile [REDACTED]). Another name provided was [REDACTED]). The caller was aware that part of the internal process involved contacting DCFS. I informed the caller that I would have to reach out to DCFS and the parents to determine if they wished to file a police report and provide specific information and evidence in which to move forward with.

On this date I made contact with DCFS. I was informed that [REDACTED]
